Stray Cats Becoming a Nuisance to Residents

Recently, there have been several sightings of stray cats roaming through our neighborhood. Many neighbors have complained to the Association about this increasing number of stray cats and about the homeowners who feed them.

For your safety, the ADHA recommends that you do not feed stray cats. Research shows that when cats aren't domesticated, they are and act like wild animals. They can carry rabies that will enter a human system with a simple scratch or even a lick to an open wound.

Without having been vaccinated, cats can be the carriers of a multitude of diseases. Rabies is the most obvious and dangerous, but ringworm and other types of fungal infections also are common. Keeping away from stray and outdoor cats is the best method of protection against disease; however, the germs can also be spread through excrement. Since there aren't any litter boxes around, the cats relieve themselves in the areas they inhabit outside.

Also, please be aware that in the City of Smyrna, any person who harbors a cat shall be responsible for ensuring that the cat is in compliance with the provisions of Chapter 14 – Animals; Article III, Cats. By Harbor, the Ordinance means "to give or allow to be given habitation, shelter, refuge, or nourishment for any period, whether or not owned." And if you choose to harbor a stray cat, you must abide by the above City Ordinance and the ones listed below:

- Sec. 14-71. Vaccination and tags required.
- Sec. 14-73. Limit on number of cats harbored.
- Sec. 14-72. Running at large while in heat.
- Sec. 14-69. Responsibility of harborer to comply with article.
- Sec. 14-70. Unlawful presence.
- Sec. 14-67. Penalty for violation.

Please, for your protection, refrain from petting stray cats and do not encourage the strays to hang around by feeding them. Once you start to feed one stray cat, more will appear and they will continue to appear regularly.

To report strays, please contact the local Animal Control department at 770-434-6600. That department is in charge of finding homes to place these stray, feral and/or alley cats.

For close to 20 years now, the Afton Downs community has been and continues to be one of the kept secret in Smyrna. In large part, this is due to the efforts and commitment of all the homeowners who have worked hard to maintain their homes and the beauty and charm of the neighborhood. This appeal and charm are exactly why homebuyers choose our community over many other surrounding communities.
